## Understanding the Family Supplemental Subsistence Allowance

## Overview

The Family Supplemental Subsistence Allowance Program supports eligible service members with large families. Read on to learn more about FSSA and who may qualify.

**Eligibility:** Only military members serving outside the United States, Puerto Rico, U.S. Virgin Islands and Guam are eligible to apply for <u>FSSA</u>. Eligibility is based on household size and income\*



**Calculation:** A service member's household income and size are factors when calculating a possible monthly stipend. The standards are the same as those for the federal <u>Supplemental Nutrition</u> <u>Assistance Program</u>, or SNAP. DoD 7000.14-R, Volume 7A, Chapter 25, "Basic Allowance for Subsistence" outlines additional FSSA information.

**Amount:** FSSA payments to qualifying service members will not exceed \$1,100 per month. Applicants should note that these funds may impact a household's eligibility for other federal programs such as SNAP; food assistance for <u>Women, Infants, and Children</u>, or WIC; and subsidized school-meal programs.

**Application:** To apply, fill out the FSSA application, <u>DD Form 2857</u>. It requires certain personal information. Prepare beforehand by gathering the following:

- Basic pay and pay entry base date
- Basic Allowance for Housing, Basic Allowance for Subsistence and Overseas Housing Allowance
- Special pay and allowances
- Any other household income

The appropriate service organization will make all decisions regarding eligibility, entitlement amount and final certification for payment. Any inquiries should be directed to service personnel centers.
