## Talking to Service Members **About Filing Taxes**

- "Did you know that being deployed to a combat zone qualifies you for an automatic extension on filing and paying your taxes?"
- "Congratulations on your marriage/new child/ recent home purchase! Have you considered how this new milestone may affect your taxes?"
- "Do you know when you may need to file an amended return and how to do so?"
